Α. I'm disfellowshipped. 1 2 Q. Anything else? 3 Α. No. 4 Ο. Did you ever talk to Shirley about the 5 sexual abuse that you're alleging against Bruce, Sr.? 6 7 Α. Yes. 0. When? 8 9 After it happened --Α. 10 Q. Can you ---- with Gunner. 11 Α. 12 Ο. After it happened with Gunner. Is that 13 what you said? Mm-hmm. That's the first that I was made 14 Α. 15 to tell her what had happened. 16 How old were you? Ο. Okay. Somewhere between nine and 17 Α. Ten. Nine. ten. 18 19 And who made you tell her? Ο. 20 Α. Bruce Mapley, Sr. We'll talk about that more here in a 21 Ο. 22 minute, but other than that instance when you were 23 ten or so, have you talked to Shirley about these 24 allegations at any other time? 25 Α. SHAFFER: Object to form. 11 The night that Gunner sexually molested Α. 12 me, not long after that, he called Bruce, Sr. to My father 13 tell him what he had just done to me. 14 came and picked me up from the home, Gunner Hain's 15 home, and in the car my father asked me if Gunner had done something to me, and he made me tell him 16 17 what Gunner had done to me. 1 Approximately seven years old? Ο. 2 Α. Yeah. And so when did the sexual abuse by 3 Ο. Okay. 4 Bruce start? How old were you? 5 Α. I was very young. I was probably somewhere around the age of five. 6 7 Ο. And where were you living at that time? I recall -- My memory is I recall it 8 Α. 9 happening in Michigan. 10 So it occurred before you were back to Ο. 11 Montana. 12 Α. Yes. 13 And continued to occur after you moved Ο. 14 back to Montana. 15 Α. Yes. 16 Ο. Is that true for Cami as well, do you 17 know? 18 Α. Yes. 19 Have you spoken to Cami about that? Ο. 20 Α. Well, it happened with us together, so we already know about that. As far as talking about 21 22 it, I -- I'm sure that we have, yes. 23 Okay. Before you moved back to Montana, Ο. 24 where did the abuse occur? Was it in a home, 25 someplace else? 84

1 Α. With me it was in my home. 2 also -- He would take me to other people's homes 3 when they were not home and sexually molest me in 4 other people's homes. 5 He would take you to just vacant houses Ο. 6 and molest you there? 7 Α. I'm assuming that they were people he was friends with and had access to their home. 8 9 Ο. Okay. I don't know. 10 Α. I can't say. At that point before you moved back to 11 Ο. 12 Montana, what did the sexual abuse consist of? 13 Α. Gratifying him through oral sex, him lubing up my legs with Vaseline and making me 14 15 cross my legs really tight and placing his penis 16 close to my vagina and motioning in a sexual 17 manner to gratify himself. Fondling or groping my genitals, making me kiss him as I was a -- like a 18 19 lover. Just touching, fondling, groping, and just 20 gratifying him in any way that gave him sexual 21 pleasure. 22 Ο. Before -- At that time before you moved 23 back to Montana, did -- how often would this 24 happen? 25 Α. Every time my mom would leave the house. 85

Was that weekly, daily? Can you give me 1 Ο. 2 an idea of how often? I understand she was on a bowling league, 3 so it could be several times a week. 4 5 Did anybody ever witness this? And I'm Ο. talking about the period before you moved to 6 7 Montana. Α. 8 No. 9 The complaint says that you or your family joined the Hardin congregation in 1973. Is 1973 10 11 also the year your family moved back to Montana? 12 Α. I remember that I was halfway through my 13 third grade year when we moved to -- to 14 Fort Smith. 15 Okay. How long had your family lived in Ο. Montana before they joined the Hardin congregation? 16 17 Α. I was pretty young. I wouldn't be able to really give you an accurate answer on that. 18 19 This abuse from Bruce, did it continue Ο. 20 after you moved back to Montana? 21 Α. Yes. 22 Ο. And was the -- was it the same type of 23 abuse or anything --24 Α. Yes. 25 -- different? Q. 86

When did the abuse from Bruce, Sr. stop? 1 2 Α. I was 17 years old -- and about four or 3 five months old when I finally stood up to him when he tried to grope me, and I stood up and I 4 5 said, "You will never touch me again." Just so I'm clear, you're saying you were 6 Ο. 17 and four or five months old? 7 Α. Mm-hmm. 8 9 During that time between when you were five and when you were 17 -- I'll just say 17 and a 10 11 half, I know it was less than that, but 17 and a 12 half, did -- was the abuse always the same or did 13 it change throughout the years? 14 Α. I would say that there was times it was 15 different for -- Are you asking for an instance? 16 What are you asking for? 17 Ο. I'm just asking, you -- you described in detail what the abuse consisted of before you moved 18 19 back to Montana. I'm curious if that changed at 20 all after you moved back to Montana or if it was 21 the same. 22 Α. It was basically the same, and there was 23 a lot of groping, touching, using me to gratify 24 himself. 25 Talking about when you're now in Montana Q. 87
